PLEASE READ CAREFULLY – THIS IS A LEGAL DOCUMENT.

LIABILITY RELEASE. I, the parent or legal guardian of the minor child named above, understand that there are risks inherent in my child/ ward's participation in this drama class (which may be referred to as a "drama club," "drama camp," "drama workshop," or similar term) sponsored by Drama by George LLC, which is scheduled to be held at the School or Hosting Organization named above during the academic semester specified. The risks to my child/ ward may include, without limitation, personal injury and the loss of personal property. I hereby agree to release, indemnify, and hold harmless Drama by George LLC and the School or Hosting Organization; together with their directors, members, partners, employees, contractors, volunteers, agents, and assigns; from any and all claims which I or my child/ ward may have for any losses, damages, or injuries that are in any way related to my child/ ward's participation in the drama class.

I understand that my child's Content is not guaranteed to appear in an online gallery or to be publicly exhibited in any way. I waive any right which I or my child/ ward may have to inspect or approve the Content prior to its use. *Note: If you do NOT wish to grant permission for your child to be photographed and/ or recorded, DO NOT SIGN THIS FORM. LATE PICKUPS. I understand that if I pick up my child more than 10 minutes after the scheduled ending time for the drama class, I may be charged a late fee which must be paid before my child may return to drama class. If I pick up my child 30 or more minutes late, I understand that my child will not be permitted to return to drama class and no refund will be issued.
